OFFICER MEEK SAID THAT THE TWO WERE HAVING A FIGHT EARLIER IN THE DAY ABOUT RELATIONSHIPS AND ELYCIA SAID IT WAS INTENSE. ELYCIA SAID THAT FRANCISCO GRABBED A GUN AND HELD IT TO HIS HEAD, POSSIBLY WITH INTENT OF COMMITTING SUICIDE. ELYCIA SAID SHE BECAME WORRIED ABOUT FRANCISCO'S SAFETY, AND CALLED ONE OF HIS BAND MATES TO TAKE HIM TO THE HOSPITAL.

ELYCIA SAID THAT WHEN FRANCISCO WAS IN THE HOSPITAL, SHE HID THE GUN IN A CLOSET.

SHE CONTINUED TO SAY THAT WHEN HE CAME BACK FROM THE HOSPITAL, THE FIGHT CONTINUED. ELYCIA SAID THAT FRANCISCO PUNCHED HER IN THE BACK OF THE HEAD, AND THREW HER INTO A WALL WHILE IN THE DOWNSTAIRS BEDROOM.

- I LOOKED AT ELYCIA AND ALTHOUGH SHE SHOWED SIGNS AND SYMPTOMS OF DRINKING ALCOHOL, SHE DID NOT HAVE ANY VISIBLE SIGNS OF INJURIES.
- I RETURNED DOWNSTAIRS AND SPOKE WITH FRANCISCO. I ASKED HIM IF HE PUT A GUN TO HIS HEAD, AND HE SAID "NO." HE SAID "I GRABBED THE CASE, BUT NOT THE GUN." FRANCISCO SAID "IT ISN'T EVEN LOADED". FRANCISCO SAID "IT WAS EXTREMELY EMOTIONAL."
- I ASKED FRANCISCO IF HE PUNCHED ELYCIA, AND HE SAID "NO. I LOVE HER TOO MUCH. SHE IS THE WOMAN I WANT TO MARRY." $(x,t) \notin \mathcal{F}(\mathcal{F}) \times \mathcal{F}$
- I ASKED ELYCIA TO SHOW ME WHERE SHE HID THE GUN, AND SHE WALKED ME TO ONE OF THE DOWNSTAIRS CLOSETS. SHE POINTED TO A BLACK GUN CASE, AND I GRABBED IT. INSIDE THE CASE, I RETRIEVED A BLACK SEMI AUTO .380 GUN. I STRIPPED THE MAGAZINE FROM THE WEAPON, AND NOTICED BULLETS IN THE MAGAZINE, BUT NONE WERE IN THE CHAMBER.
- I RETURNED THE GUN TO THE CASE, AND SECURED IT IN MY VEHICLE.

BOTH FRANCISCO AND ELYCIA WERE ADVISED THAT THE WEAPON WOULD BE IMPOUNDED FOR SAFEKEEPING, AND I SUPPLIED FRANCISCO WITH THE LOCATION OF 100 E ELWOOD TO RECLAIM HIS PROPERTY.

SINCE THERE WERE NO SIGNS OF INJURY, NO SIGNS OF DAMAGE, AND NO INDEPENDENT WITNESSES OR OTHER PERSONS INVOLVED, BOTH WERE WARNED FOR DISORDERLY CONDUCT.

ATTEMPTS WERE MADE TO HAVE EITHER PARTY LEAVE, AND BOTH REFUSED. I WARNED BOTH OF THEM THAT IF POLICE RESPOND TO THIS ADDRESS, ONE OR BOTH OF THEM WILL BE CHARGED WITH DISORDERLY CONDUCT AND BOOKED INTO JAIL.

FRANCISCO AGREED TO SLEEP IN THE DOWNSTAIRS BEDROOM, AND ELYCIA AGREED TO SLEEP IN THE UPSTAIRS BEDROOM.

BOTH MYSELF AND OFFICER MEEK LEFT THE RESIDENCE.

ON 2/11/11 AT 2218 HOURS, V1/SP1 FRANCISCO AND V2/SP2 ELYCIA COMMITTED DISORDERLY CONDUCT BY FIGHTING WHILE INSIDE THEIR RESIDENCE AT UPON POLICE ARRIVAL, NO EVIDENCE OF A FIGHT UPON POLICE ARRIVAL, NO EVIDENCE OF A FIGH OR STRUGGLE WAS SEEN. A HANDGUN WAS IMPOUNDED FOR SAFEKEEPING, AND BOTH WERE WARNED THAT FUTURE ACTIONS WOULD RESULT IN INCARCERATION.

ON 2/11/11 AT 2218 HOURS, MYSELF AND OFFICER MEEK #7668 RESPONDED TO IN REFERENCE TO AN EMERGENCY CALL OF DOMESTIC VIOLENCE. THE NOTES ON THE CALL STATED THAT A FEMALE WAS THROWING THINGS AND HITTING THE COMPLAINANT.

UPON OUR ARRIVAL AT 2222 HOURS; WE WERE GREETED AT THE DOOR BY V1/SP1 FRANCISCO. I SPOKE WITH FRANCISCO AND OFFICER MEEK SPOKE WITH V2/SP2 ELYCIA. FRANCISCO TOLD ME THE FOLLOWING:

FRANCISCO SAID THAT EARLIER IN THE DAY, AROUND 1400 HOURS, THERE WAS AN ARGUMENT BETWEEN THE TWO OF THEM ABOUT PRIOR RELATIONSHIPS. FRANCISCO TOLD ME THE ARGUMENT WAS YELLING AND SCREAMING, AND NOTHING PHYSICAL. FRANCISCO SAID THAT DURING THE ARGUMENT, HE FELL AND HIT HIS HEAD. FEARING THAT HE MAY HAVE A CONCUSSION, HE CALLED A FRIEND TO TAKE HIM TO THE HOSPITAL.

FRANCISCO SAID THAT HE CHECKED INTO ONE OF THE HOSPITALS ON MCDOWELL, BUT LEFT BEFORE GETTING MEDICAL TREATMENT BECAUSE "HE WAS FEELING BETTER".

FRANCISCO RETURNED HOME AND EVERYTHING WAS FINE. HE SAID HE WENT TO BED IN THE LOWER BEDROOM, AND WAS AWAKENED BY V2/SP2 ELYCIA YELLING AT HIM AND HITTING HIM IN THE FACE ABOUT PRIOR RELATIONSHIPS.

FRANCISCO SAID THAT ELYCIA DEMANDED HIS LAPTOP COMPUTER, AND FRANCISCO BECAME WORRIED THAT THE COMPUTER WOULD BE DESTROYED, STATING THAT THE COMPUTER CONTAINS IMPORTANT BAND AND MUSIC INFORMATION ON IT.

FRANCISCO SAID HE WAS DEFENDING HIMSELF AND TRYING TO GET HIS COMPUTER BACK, WHEN ELYCIA FELL TO THE GROUND, AND STARTED TO KICK THE BEDROOM

FRANCISCO SAID HE WAS SCARED THAT THIS WAS GETTING OUT OF CONTROL, SO HE CALLED POLICE.

THERE WERE NO VISIBLE INJURIES ANYWHERE ON FRANCISCO, NOR DID I NOTICE ANYTHING BROKEN OR ANY PROPERTY DAMAGE INSIDE THE RESIDENCE.

WITH THIS INFORMATION, I SPOKE WITH OFFICER MEEK WHO WAS TALKING TO V2/SP2 ELYCIA. OFFICER MEEK TOLD ME THE FOLLOWING:
